Portfolio Manager Commentary

The JSE All-Share index returned around 4.8% for the month to reverse the negative return of approximately the same amount during the market selloff in May. Resource stocks lead the rebound with a monthly return of 10.1%. There was also some muchneeded respite for the Rand which strengthened against all major developed market currencies and was almost 4% up against the US Dollar.

At the global index level, equity, bond and property markets are all exceedingly expensive. The US S&P 500, Dow and Nasdaq are trading at all-time highs with aggregate corporate bond and real estate indices also priced at historically elevated levels. July 2019 also marks the longest running US economic expansion on record at 121 months. Europe is experiencing the peculiarity of negative nominal government bond yields, which means that investors are actually paying governments to hold their money. The value of global negative yielding government bond debt is now a staggering \$13 Trillion - again the highest level in history.

These anomalies are further evidence of investors taking on increasingly higher levels of risk to generate what we consider to be below par returns. After reviewing market conditions over the first half of the year we are seeing further evidence to support our cautiously opportunistic approach. The companies which meet our minimum investment criteria are still trading on the expensive side of what we would consider a fair price, but we are slowly uncovering more ideas which improve the expected return profile of the fund without compromising portfolio robustness.

Investment Objective

The Fund aims to provide investors with long-term investment returns after costs at or above its benchmark of the South African inflation rate plus 5%.

Investment Strategy

The Fund complies with Regulation 28 of the Pension Funds Act and may invest up to maximums of 75% in equities and 25% in offshore assets. The Fund will invest in a diversified range of equities, investment grade bonds, property and cash, but may also invest in preference shares, currencies and commodities when sensible opportunities present themselves. The flexibility of this mandate empowers the fund managers to be more fully invested when a diversified selection of good assets are cheap and to be positioned defensively when good assets are very expensive or highly concentrated in a single sector.

Suitability

The Fund is most suited to investors with an investment horizon of five to ten years seeking a combination of principal preservation, income generation and long-term capital growth.

Tax Free Investment

Based on section 12T of the Income Tax Act this Fund qualifies as a tax-free investment account ("TFSA"). This allows South African individuals to qualify for no tax on distributions and / or capital gains while invested in the Fund. The current tax framework limits contributions to tax-free investments to R₃₃ 000 per tax year with the lifetime limit capped at R₅00 000. Any contributions exceeding these limits will be subject to tax. It is recommended that any investor considering investing in the Fund for specific tax purposes and requires explicit tax advice consult directly with a qualified tax professional. What It Really Means
