Portfolio Manager Commentary

February 2020 was a particularly tough month in local and global investment markets with meaningful declines in equity indices. Looking at the underlying index constituents – the thousands of companies that make up the market as a whole – it was significantly worse, as well as wide-spread across countries, sectors and industries.

As you can see from our negative February fund price change, we have clearly not fully escaped this, but our significant holding in cash and near-cash helped to soften the blow - as it was intended and expected to.

Media coverage and consensus appears centred on the negative economic and market impact of the Coronavirus. However, we feel the truth is the evidenced reality that at equity index levels markets are quite simply overvalued. That people need to find a story to help explain the times is as old as time. This is in the nature of investing and we feel it is important for us to both appreciate and respect this. Our point is that laying the blame for market declines at the door of the critically endangered and beautiful Pangolin could be a mistake.

Amid all this external noise our team continue to scrub annual reports and evaluate existing and new investment ideas. Most importantly, the incredible quality of our investor base and our ability and commitment to stay well under the radar gives us a firm bedrock from which to calmly go about deploying our fund cash into only the very best investment opportunities on your behalf. The volatility and declines in markets are dishing up increasingly attractive long-term investments in quality, scale businesses with strong balance sheets and free cash flows. The good news is there is no need to swing for the fences by buying a host of poor quality, sub-scale companies with poor balance sheets and free cash flows that are between unlikely and certain to be wiped out in an economic recession. We have slowly but surely been adding to our existing top-quality holdings and adding a few new ones.

Please know we remain as discerning as ever and we are under no pressure nor in a hurry to become fully invested. As and when top quality assets become available at increasingly attractive prices, we will buy into them in a disciplined manner.

You can expect to receive a letter from us soon with a more detailed reflection on our investment actions and outcomes over the past 2 ½ years, as well as our current fund positioning and investment outlook.

Investment Objective

The Fund aims to provide investors with long-term investment returns after costs at or above its benchmark of the South African inflation rate plus 5%.

Investment Strategy

The Fund complies with Regulation 28 of the Pension Funds Act and may invest up to maximums of 75% in equities and 30% in offshore assets. The Fund will invest in a diversified range of equities, investment grade bonds, property and cash, but may also invest in preference shares, currencies and commodities when sensible opportunities present themselves. The flexibility of this mandate empowers the fund managers to be more fully invested when a diversified selection of good assets are cheap and to be positioned defensively when good assets are very expensive or highly concentrated in a single sector.

Suitability

The Fund is most suited to investors with an investment horizon of five to ten years seeking a combination of principal preservation, income generation and long-term capital growth.

Tax Free Investment

Based on section 12T of the Income Tax Act this Fund qualifies as a tax-free investment account ("TFSA"). This allows South African individuals to qualify for no tax on distributions and / or capital gains while invested in the Fund. The current tax framework limits contributions to tax-free investments to R36 000 per tax year with the lifetime limit capped at R500 000. Any contributions exceeding these limits will be subject to tax. It is recommended that any investor considering investing in the Fund for specific tax purposes and requires explicit tax advice consult directly with a qualified tax professional. What It Really Means

Long-Term: An investment period of five to ten years.
